

## ENTRY FORM - 2010 Whiskey Joe's Tampa Bay Marathon Swim

The Thirteenth Annual Whiskey Joe's 24 Mile Tampa Bay Marathon Swim will be held on Saturday, April 17, 2010. This race is sanctioned by Florida LMSC for USMS Inc., Sanction #140-008ow, and current USMS (United States Masters Swimming) Long Distance Swimming rules govern this swim. ALL participants must be 18 years or older and registered with USMS. One day USMS Registrations are available, and foreign swimmers may also compete if they provide an introductory letter from their country's national governing body.

Each solo entrant will be assigned an escort power boat, receive a t-shirt, and a custom designed award for completing the swim. There is also recognition for the USMS male and female age groups 18-24, 25-29, 30-34, etc... as high as necessary. The swimmer's age on race day determines their age group.

Each relay entrant will receive one t-shirt and a custom designed award at the finish. There is recognition for the top three male, female and mixed relays of three or six swimmers. Relay swimmers must be escorted by an escort craft at all times and competitors are free to make transitions at any point during the race.

The start and finish will take place "in-the-water." Current USMS rules regarding swim suits will be observed. Absolutely no fins, pull buoys, leg floats, webbed gloves, wet suits, or other possible speed-increasing devices will be allowed in the competition. Swimmers may not stand on, nor push off the bottom of Tampa Bay. Shallow areas are a danger for both swimmers and boaters so navigational planning is extremely important.

Swimmers in Whiskey Joe's Tampa Bay Marathon Swim must be accompanied by a powered escort boat during the swim. NO ESCORT-NO SWIM. Although not required, many competitors also secure a human-powered craft such as a kayak or canoe. For competitors who are unable to bring their own escort craft and crew, a limited number of powerboat rentals(manned and unmanned) and kayak rentals (manned and unmanned) are available on a first-come, first-served basis. Discounted entry fees are offered to entrants who are able to provide their own powered escort boat.

Swimmers may not touch their boat or crew at any time with the exception of relay transitions. Make sure that you have plenty of food, water and/or sports drink for swimmers and support crew. The average water temperature for Tampa Bay in April is 75 degrees Fahrenheit (25 degrees Celsius).

The starting line is the Holiday Inn Sunspree Resort - 6800 Sunshine Skyway Lane; St. Petersburg, Florida 33711. Phone: 800.227.8045. If you choose to lodge at there, please reserve your room early and be sure to request the discounted marathon swim room rates.

At 6:00pm on Friday evening, April 16th there will be a rules and competition meeting for swimmers, boaters, kayakers and crew members. Course maps, t-shirts and swimmers' packets will be available at check-in headquarters located at the Nepa Hut/starting line beach area behind the Holiday Inn Sunspree Resort. The hotel's marina is also available for overnight boat storage conveniently located 50 yards from the starting line. Call the hotel and ask for the Dockmaster if you would like to reserve a slip in their marina.

Every effort will be made to start the swim at 7:15am on Saturday, April 17th. Check-in time begins at 6:00am. If weather conditions are dangerous(high winds, thunderstorms, poor visibility) the start may be delayed or rescheduled to the next day. Due to the nature and complexity of this event, no refunds will be given.

The Finish Line is located at Whiskey Joe's Restaurant - 7720 W. Courtney Campbell Causeway; Tampa, Florida 33607. Phone: 813.281.0770. The fastest competitors should start arriving around 4:00pm and the awards celebration will last until 9pm, or when the last competitors reach the finish line.
